

## Sweepstakes Rules

### 1. Eligibility

ZCON Nissan Z Giveaway Sweepstakes (the "Sweepstakes") is open to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. ### 5. How to Enter

**Online:** This method of entry will be available by visiting our website ([www.zcon.org](http://www.zcon.org)) and following the directions provided to fill out the entry information, and submit. This method will be available up to September 6, 2024, then On-Site method must be used.

**Via Mail:** This method of entry will be available for majority of the entire Sweepstakes Period. On a 3x5 card, handprint your full name, complete address, phone number (including area code) date of birth and email address (optional) and mail in an envelope with proper postage affixed to: P.O. Box 1006, Chardon, Ohio, 44024. Mail-in entries must be hand-printed and

mailed in separately. All mail-in entries must be postmarked prior to and received by September 06, 2024, one entry per address permitted. All entries become the property of Sponsor and will not be acknowledged or returned.

## **6. Prize Drawing**

On or about September 14, 2024, the Sponsor will select potential winner in a random drawing from among all eligible entries received. The odds of being selected depend on the number of entries received. The Sponsor will attempt to notify the potential winner via telephone or email on or about September 14, 2024. If the potential winner cannot be contacted within five (5) days after the date of the first attempt to contact him/her, the Sponsor may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries.

## **7. Winner Notification**

The potential winner will be notified by email, mail or phone. Each potential Grand and First Prize winner (parent/legal guardian if a minor in his/her state of residence) will be required to complete, electronically sign and submit a Declaration of Compliance within five (5) days of the date notice or attempted notice is sent, in order to claim his/her prize. If a potential winner cannot be contacted, or fails to submit the Declaration of Compliance within the required time period (if applicable), or prize is returned as undeliverable, potential winner forfeits prize. ## **9. General Conditions**

Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to damage the website or undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages (including attorney's fees) and any other remedies from any such person to the fullest extent permitted by law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision.
